CADMIUM IS THE REQUIRED PLATE ON MANY MILITARY PRINTS. AS WE MANUFACTURE TO THE SPECIFICATIONS OF THE PRINTS WE WILL CONTINUE TO FURNISH THESE PARTS WITH CADMIUM PLATE. THERE IS NO SUBSTITUTE FOR THIS PLATE TO DATE.

CRESCENT CAN ALREADY PROVIDE MERCURY FREE CERTS UPON REQUEST. NO MATERIAL WE PROVIDE CONTAINS ANY MERCURY.

LEAD IS PRESENT IN THE ALLOY 260 BRASS MATERIAL THAT WE NEED TO MANUFACTURE FROM. THIS IS ONLY A TRACE AMOUNT AND IS WELL BELOW THE U.S. LIMITS FOR LEAD. OUR MATERIAL CERTS INDICATE A READING OF <.01 LEAD. THE DIRECTIVE ALLOWS UP TO 4% BY WEIGHT.

HEXAVALENT CHROMIUM IS ALSO NOT AN ISSUE. EFFECTIVE 7-1-05 OUR PLATERS HAVE ALL CONVERTED TO BE HEXAVALENT FREE.

STAINLESS STEELS, ALLOY STEELS, AND MILD CARBON STEEL DO NOT CONTAIN ANY OF THESE ELEMENTS AND ARE THEREFORE COMPLIANT WITHOUT EXPLANATION.

POLYBROMINATED BIPHENYLS, POLYBROMINATED DIPHENYLE ETHERS, AND DECA BROMINE DIPHENYL ETHER. ARE ALL PLASTICS RELATED AND AGAIN NOTHING THAT CRESCENT USES IN OUR PRODUCT THEREFORE NOT APPLICABLE.

THIS BEING SAID THE PARTS ARE STILL COMPLIANT TO THE REACH REQUIREMENT OF LESS THE .1% WEIGHT VS WEIGHT.
